## ***How Can I Help Influence the Political Process?***

People choose to serve in the health care community because they want to provide quality care to people in their communities.

Decisions made by our elected officials affect the way health care is delivered and impact health care jobs. That is why it is important that the hospital and health system community has a strong voice in both Harrisburg and Washington, D.C.

There are **three key ways** to influence the political process on behalf of hospitals, their employees, and the patients they serve: association lobbying, grassroots advocacy, and a strong political action committee.

Each year, hospital leaders, employees, and supporters, who care about the future of hospitals and health care, unite through The Hospital and Healthsystem Association of Pennsylvania's (HAP) Political Action Committee (HAPAC) to support elected officials and candidates for office who share our agenda and want to champion issues of importance to hospitals and their patients. The hospital community's HAPAC contributions help identify hospital and health care issues and advance the legislative agenda. The more money in HAPAC, the more effective we are.

HAPAC supports candidates for the Pennsylvania General Assembly and statewide offices, as well as Congressional candidates. A percentage of all federally qualified contributions from individuals at authorized hospitals and health systems will be transferred to the American Hospital Association's (AHA) political action committee (AHAPAC), an affiliated federal PAC.

By contributing to HAPAC, you are joining with others to create a strong, unified voice that will be listened to by lawmakers and those running for office. HAPAC is the official advocacy tool for Pennsylvania hospitals, their employees, and the patients they serve. HAPAC is strictly non-partisan and supports individuals based on their ability to work on behalf of Pennsylvania's hospital community.

Contributions to HAPAC and HAPAC-Federal are not deductible as charitable contributions. Your contribution is important to us, but we want to emphasize that all contributions are voluntary and have no impact on your job status, performance review, compensation, or employment. Any amount given or the decision not to give will not advantage or disadvantage you. All contributions will be used for political purposes. A percentage of all federally qualified contributions from individuals at authorized hospitals will be forwarded to HAPAC-Federal, which is shared with the American Hospital Association's PAC (AHAPAC), an affiliated federal PAC. Federal law requires PACs to report the name and mailing address of each contributor when contributions exceed \$50; and for any contributions aggregate in excess of \$200 in a calendar year. Corporate contributions are prohibited by law.
